Kindycube is made from 13mm panels of our rugged, solid core Compact Laminate. All doors and partitions are finished with a smooth half-round edge. There are height adjustable nylon pedestals and nylon hinges for self-closing doors. Matching fixing brackets and toilet roll holders are available.

Dimensions

As cubicles are custom made to your measurements, depths and widths can be varied to suit, while complying with the NZ building code.

The Kindycube standard dimensions are:

- Height 1050 mm with 150 mm floor clearance.
- Depth 1200 mm -1600 mm.
- Standard cubicles are recommended in an open-in door option.
- Standard cubicle doors are 525 mm (opening 450mm -500 mm).

B2.3.1 Durability Resco's products exceed requirements. Our systems are made using Compact Laminate panels that have 10 year warranty, however we expect these panels to have a serviceable life of 20+ years. (Examples: Orewa top 10 Holiday Park – over 20 years old & Waikato Stadium - over 16 years old).

E3.2, E3.3.4 Internal Moisture Resco's products comply with these requirements. Our products are made from panels that have silver-ion technology. Panels actively kill up to 99% of bacteria within 2 hours for the life of the panel. The panels are waterproof and perfect for wet areas. (Tested to ISO 22196:2011, EN 438 4:2005).

G1.3.2 Personal Hygiene Resco's products comply with these requirements. The design of Resco systems are unique, they have fewer dirt traps, improved privacy and easier to clean. GREENSTAR V3.1 - MAT-4 Improves interior air quality by reducing VOC and Formaldehyde emissions. (Greenguard gold certification).

Living Building Challenge Resco's Antibac panels are free of the ingredients appearing in the Red List Summary of the Living Building Challenge (Supplier declaration).

NZBC CVM2/AS2-AS7 Resco's panels are suitable for application in rooms with intermittent use. We typically propose our systems in toilet and shower blocks. (BRANZ testing FH 5110 - Group 3 rating).
